Christian Children's Home of Ohio (CCHO) began over 50 years ago in March 1969 when members of the independent Christian Churches/Churches of Christ movement learned of a boy with no safe place to call home. Located on a 165-acre campus in Wooster, Ohio, CCHO provides a safe and stable environment where abused and neglected children find healing, discover hope and experience unconditional love.

CCHO and our family of ministries exists to help people experience their worth in Christ. Parents and families also have access to counseling and home-based services with the ultimate goal of reuniting children with their families whenever possible. CCHO's professional programs and services are open to individuals and families.
